

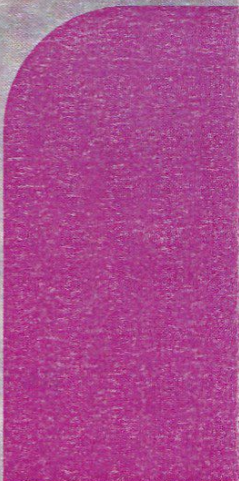

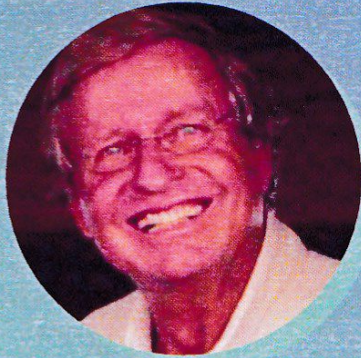

I am very much optimistic about the progress of DITO Social Welfare Association and hope future will bring more possibilities for the organisation to reach out to the unreached.

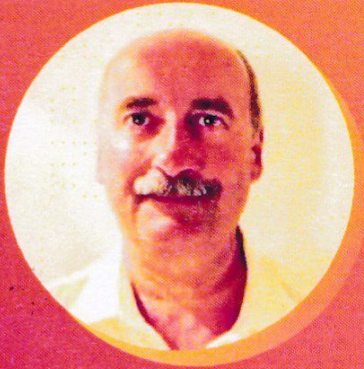

What We Do

We reach out to the unreached population primarily women and children to provide health car facility at the doorstep by means of Mobile Medicare Van in Howrah district and thus ensuring Accessibility, Availability & Affordability of Health care. Accessibility to safe drinking water for the family is considered as the duty entrusted with women in Indian society. We make their life easier by installing community drinking water purification system with Reverse Osmosis technology. Water plant at Tikiapara Howrah caters to the urban slum population. To realise the full potential of our society, we ensure that girls from marginalised community should not drop out from higher education due to financial crunch. DITO is providing financial support to 21 girls from impoverished background and thus assisting them to continue their education.

We encourage women to talk about issues which are considered as feminine, taboo and shouldn't be spoken in public. Menstruation is one such issue. We start dialogue with rural community on Menstrual hygiene management, so that women get correct knowledge and break the barriers that are associated with menstruation.

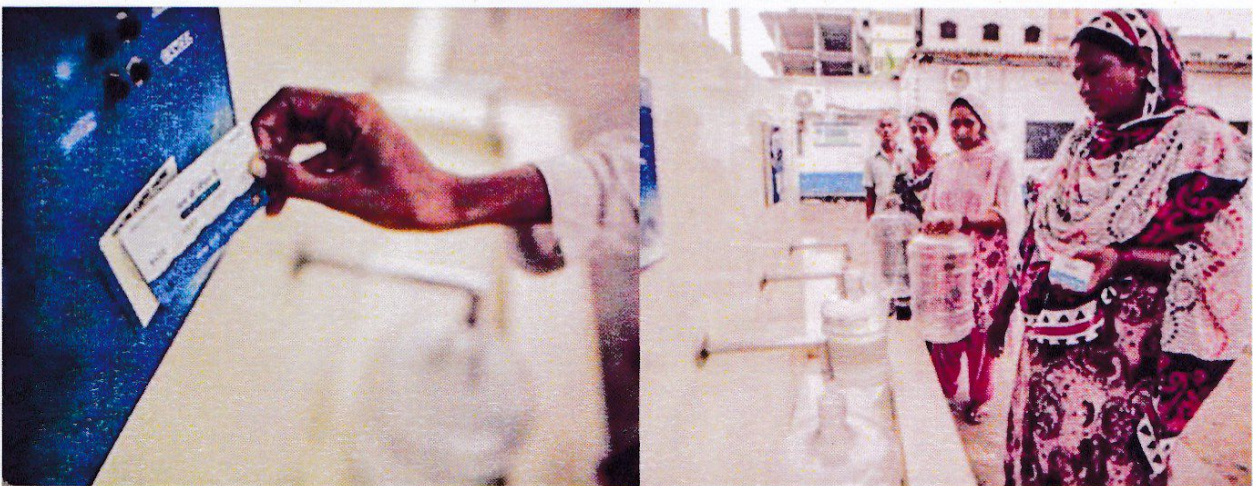

Education plays an important role in the development of a country. Women, being the second class citizen, are still deprived of education in many parts of India. A country's progress in entirety depends on the rate of proper education which is more than just being literate. In our country, a family prioritizes a daughter's marriage more than her education. A loving family saves money for the girl's marriage and teaches her to dream of a successful marriage and not a successful career, despite the capabilities and expertise she possesses. However, there are exceptions too; but their financial status restrains such talents to spread their wings. This is where DITO seeks to intervene.

The Impact Of DITO Scholarship Programme



Family income increases considerably.

Example: Rituparna now earns a salary of 40,000/- INR per month. Previously, her family income was 5,000/- INR per month



The nutrition level of the family increases.



The chance of other siblings dropping out from schools, minimizes



The mother who previously worked as a domestic help, can now spend time at home and look after her other children.



Education prevents early marriages and thus, adolescent marriage can be prevented.

Example: Dipali Kar who was studying English Honours with DITO scholarship, didn't follow the family tradition of early marriage and instead, continued pursuing her education.



Education gives economic empowerment as well as subsequent independence in choosing a suitable life partner.

Menstrual Hygiene Management Programme

Menstruation is the most natural bio-physiological phenomenon in a women's life cycle, indeed of human existence, and menstrual hygiene is fundamental to the dignity and wellbeing of women and girls. Although menstruation is a part of the maturation process, but it is often, culturally defined as the indicator of girl's maturity and readiness for marriage and sexual activity. Many studies have revealed that most of the adolescent girls had incomplete and inaccurate information about the menstrual physiology and hygiene. It also revealed that mothers, television, friends, teachers and relatives were the main sources which provided information on menstruation to the adolescent girls. A study from UNICEF reveals that 1 out of 3 girls in south Asia knew nothing about menstruation prior to getting it. Menstruation is still regarded as something unclean or dirty in Indian society and it is strongly related with misconceptions and cultural restrictions in the daily normal activities of the girls and women creating various psychological stress. 48% of girls in Iran and 10% in India believe that menstruation is a disease.

DITO has undertaken a pilot study to gain an insight into the menstrual hygiene management practices of the women and young girls in randomly selected 3 villages of Uluberia - I block (Kamalachowk, Basudevpur and Jagarampur) of Howrah district.

During the pilot survey 175 (59- Jagarampur+ 66-Kamala Chowk+50 Basudevpur) respondents were spoken. All respondents spoken to were women and girls in the reproductive age group.

The key findings of the survey are:

62% (108) said they use cloth as a menstrual absorbent; only 36% (64) use sanitary napkins. Strikingly 2% (3) refused to share anything about their menstrual habit.

69% (75) of cloth users refused to share how they dry their menstrual cloth, remaining 31% (33) cloth users shared they dried it in the sunlight.

82% (53) napkin users shared they tend to throw the napkin in any available open space; only 14% (9) napkin users said they wrap and throw the napkin in garbage vat

99% (174) shared they did not visit a temple or participated in any religious activity during menstruation.

76% (134) shared they never attended any social event during their menstruation.

The above data further corroborates and establishes our assumption and need for breaking the silence around menstruation.





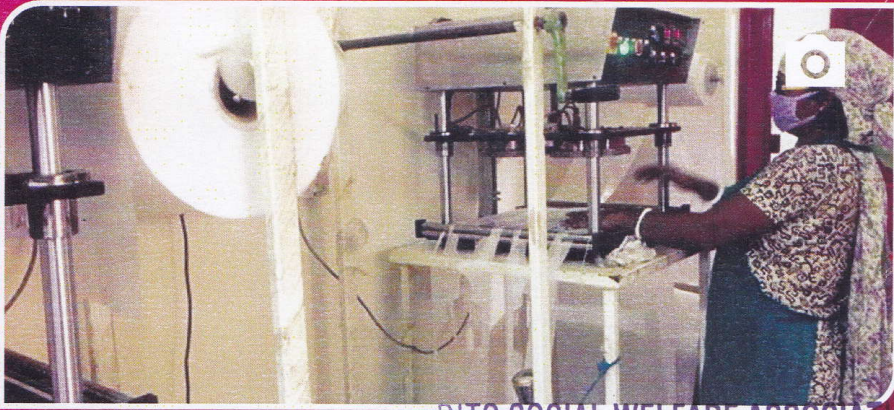
About 70% of the girl students report to miss 3 days of schools per month, which translates to a loss of 24 school days per year. This represents around 10% of a girl pupils attendance missed due to menstruation; a majority of these girls note that they are physically sick and weak, cannot concentrate, or feel psychologically effects. On the other responds shown in the survey that women in workplace generally missed 2 to 3 days from their workplace during menstrual period. Our surveys have shown that mostly, it happens for those working women, who are engaged in physical labour.

With these results, DITO wasted no further time to envisage a comprehensive advocacy and awareness campaign in Uluberia- I block of Howrah district with the objective of to create an enabling environment and facilitate the marginalized and vulnerable rural populations to address their concerns around menstrual hygiene management and better their quality of life. Till date, 10 awareness cum training meetings were organized at 10 different places reaching 330 beneficiaries who are ASHA workers, Anganwadi workers and general people.



MOUSUMI KHATUN

"I come from a remote village in Murshidabad called Bhalkundi. My family - my mother is a housewife and my father a construction laborer. My family used to depend on my father's meagre salary. Things changed drastically when my father got married elsewhere and abandoned us, and soon after even my mother got married to someone else. Within extreme poverty, I had to come face to face with emotional and psychological upheaval. My maternal grandfather then came to my aid. Thanks to the support I got from him and my teachers, I managed to do well in my studies and got admission in a premier institution like Jadavpur University for my M.A. in Philosophy. With the help of DITO's scholarship, I have passed my M.A. exam successfully and am looking forward to continue my studies by doing my M.Phil. Hopefully, I will be able to continue my studies even further and do a PhD from a university of repute."





DEBOLINA DUTTA

"I come from Cossimbazar in Murshidabad. My father is a goldsmith and my mother is a house wife, so my family income is less than Rupees 5000 a month. I wanted to continue studying and I managed to score high marks in all my exams and join B.Tech in Murshidabad College of Engineering and Technology. But it was getting difficult to pursue my studies in these sore financial circumstances. This is when I heard about the scholarship by DITO from the principal of my college. I applied and received the scholarship. This has helped me a great deal in staying focused on my studies and scoring an SGPA of 8.8. I wish to study more and also get a job to make sure that I am able to take care of my family."



ARPITA SEN

"I come from a low income family in Paschim Putiary, Kolkata. My family was living on my father's meagre pension of Rupees 2000/month till my brother left his studies to support our family by earning Rupees 5000 a month. Within such financial hardships, I still managed to do very well in my exams and take admission in BSc (Nutrition) in Calcutta University. But I did not want my education to be a burden on my brother. This is when I found DITO scholarships. At first, I was hesitant about the scholarship. I thought my profile would not be accepted. But it came as my best friend and approved the entire cost of my education. I am forever indebted. I have already taken admission in MSc at Indian Institute of Engineering Science & Technology. I need scholarship to continue my studies and also a part time job to ease the pain of my family."

My sister manages our household somehow by providing private tuitions. Despite very difficult financial conditions, I managed to score good marks in my exams and took admission in B.Tech at Bengal Institute of Technology. Even though paying my fees were getting increasingly difficult, I can proudly say that my family never gave up on me and my education. Their hopes of a better future rest on me. This is when I found, applied, and was approved for the DITO Scholarship. It really went a long way in supporting me and I achieved an 8.09 CGPA in my graduation. I want to study more but I am also looking for a job to be able to support my family."

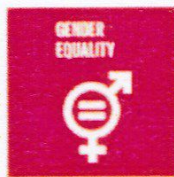
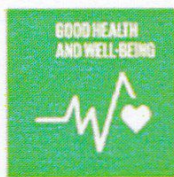

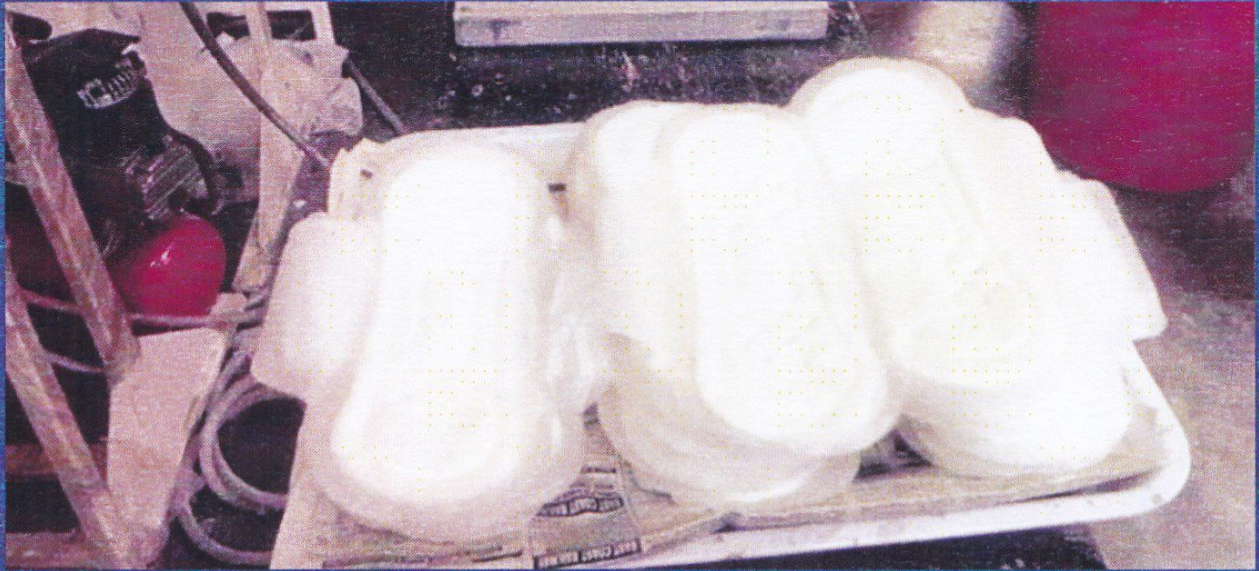

Training of Community Health Workers and DITO Team



INDEPENDENT AUDITORS' REPORT

TO THE MEMBERS OF DITO SOCIAL WELFARE ASSOCIATION

Report on the Financial Statements

We have audited the accompanying financial statements of Dito Social Welfare Association ("the Company"), which comprise the Balance Sheet as at 31 March 2018, the Statement of Income and Expenditure, the Cash Flow Statement for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Notes on Financial Statements

- 1 The Company is a non-profit organization registered as Section 8 Company under Companies Act 2013. The Company has been formed for the welfare of the under privileged women/girls. Temporary surplus funds are deployed for safe keeping, hedge against inflation and to earn some benefits by way of interest which will be used to meet capital expenses for improvement of own infrastructure.
- 2 **Significant accounting policies**
 - A **Basis of accounting and preparation of financial statements**

The financial statements have been prepared to comply in all material aspects with the applicable accounting principles in India, including Accounting Standards notified u/s 133 of the Companies Act, 2013 and the relevant provisions of the Companies Act, 2013.
 - B **Basis of Accounting**

The financial statements have been prepared under the historical cost convention on an accrual basis.
 - C **Use of estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent liabilities at the date of the financial statements and the results of operations during the reporting period. Although these estimates are based upon management's best knowledge of current events and actions, actual results could differ from these estimates.
 - D **Fixed Assets**

Fixed Assets are stated at cost of acquisition inclusive of duties (net of CENVAT and other credits, wherever applicable), taxes, incidental expenses, erection / commissioning expenses and borrowing costs etc. up to the date the assets are ready for their intended use. An impairment loss is recognized where applicable, when the carrying value of tangible assets of cash generating unit exceed its market value or value in use, whichever is higher.
 - E **Depreciation**

Depreciation has been provided as per Section 123(2) and Schedule II of the Companies Act, 2013.
The intangible assets such as software the useful life is 5 years and depreciation is charged under Written down value method
 - F **Revenue recognition**

All income is accounted for on accrual basis. Further, the same is amortised over the period of project to which the revenue is allocated.
 - G **Taxation**

Since the activities of the Company are non-profit, the surplus should not be taxable. However, the Company has not been registered U/s 12AA of Income Tax Act, 1961, its operations shall be subject to Income Tax. Hence, provision for income tax has been created on income.
 - H **Provisions**

A provision is recognised when the company has a present obligation as a result of past event and it is probable that an outflow of resources will be required to settle the obligation, in respect of which reliable estimate can be made. Provisions are not discounted to its present value and are determined based on best estimate required to settle the obligation at the balance sheet date. These are reviewed at each balance date and adjusted to reflect the current best estimates.
 - I **Cash and Cash Equivalents**

Cash and Cash Equivalents in the Cash Flow Statement comprise of cash on hand and at bank, demand deposit with banks, cheques on hand, remittances in transit and short term highly liquid investments with an original maturity of three months or less.
